#### DESCRIPTION

CURE-IT is an aqueous solution curative for curing AIR-SHIELD™ LM CO-SPRAY and MEADOW-PRUF CO-SPRAY from W. R. MEADOWS. CURE-IT is sprayed in tandem with the applicable product through W. R. MEADOWS recommended spray equipment.

#### USES

CURE-IT is used as a curative co-spray with AIR-SHIELD LM CO-SPRAY spray-applied air/vapor barrier membrane when single high-build application is desired and/or quicker set time is needed in cold weather. It is also used in the MEADOW-PRUF CO-SPRAY waterproofing membrane complete system.

- Will not cause corrosion to adjacent or embedded metal components
- Suitable for use in systems where introduction of chlorides is forbidden
- Mess-free, easy dispense with pour-spout on pails

#### ESTIMATING

One five-gal. pail of CURE-IT will typically be needed for eight five-gal. pails of AIR-SHIELD LM CO-SPRAY and MEADOW-PRUF CO-SPRAY. This ratio is highly dependent on nozzle size and spray pressures of both CURE-IT and AIR-SHIELD LM CO-SPRAY/ MEADOW-PRUF CO-SPRAY and will vary based on these conditions.
